RESOLUTION NO. 12 - 134

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER, PURSUANT TO SECTION 2-322 OF THE CITY CODE, TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH ENTERPRISE LEASING COMPANY FOR THE PROVISION OF VEHICLE RENTAL SERVICES IN AN AMOUNT NOT TO EXCEED \$45,000.00; RECOGNIZING THAT THIS AGREEMENT IS BASED ON THE EXISTING AGREEMENT BETWEEN MIAMI-DADE COUNTY AND ENTERPRISE LEASING COMPANY WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V OF THE CITY CODE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department seeks an agreement with Enterprise Leasing Company for vehicle rentals; and

WHEREAS, pursuant to Section 2-322 of the City Code, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Enterprise Leasing Company for the provision of vehicle rental services in an amount not to exceed \$45,000.00; and

WHEREAS, Staff further requests that Council recognize that this agreement is based on the existing agreement (Exhibit A) between Miami-Dade County and Enterprise Leasing Company which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V, of the City Code.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> The City Council hereby authorizes the City Manager to negotiate and enter into an agreement with Enterprise Leasing Company for the provision of vehicle rental services in an amount not to exceed \$45,000.00.
