

RESOLUTION No. 19-233

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING THE PLACEMENT OF THE DORAL MARQUEE ENTRY FEATURES AT TWO (2) LOCATIONS WITHIN THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Public Works Department (PWD) coordinated with the approved vendor to permit and install the marquees at the original proposed locations (Doral Boulevard and SR 826 and Doral Boulevard and Florida's Turnpike) presented and awarded through Resolution 18-84 at the May 2018 City Council meeting; and

WHEREAS, in coordinating with Florida's Department of Transportation (FDOT) for the necessary permit to install the marquee at the Doral Boulevard and SR 826 location, the PWD was informed that FDOT would not permit or allow the marquee to be placed within their Right-of-Way; and

WHEREAS, on January 17, 2019 at the Parks Bond Workshop the City Council members commented and suggested revisions to the concept for the Pedestrian/Bicycle Bridge that would effectively place a column in the median where the second proposed location was to be installed; and

WHEREAS, due to both conflicts, the PWD reviewed and provided new locations for the installation of the Marquees at the April 10, 2019 Council Meeting; and

WHEREAS, the Mayor and the City Council approved the median at NW 87 Ave. north of NW 12 St. location and requested the PWD to analyze other locations; and

WHEREAS, the PWD analyzed other locations and recommends the installation of the 2nd Marquee Sign at the median of NW 87 Ave. between NW 54 St. and NW 56 St.; and

WHEREAS, the PWD is providing the two locations for the Marquee Signs as depicted on the attached exhibits for approval by the Mayor and City Council members in order to proceed with the permitting and installation.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Mayor and City Council members approve the placement of the Doral Marquee Entry Features at the two (2) locations proposed depicted on the exhibits which are attached hereto as Exhibit "A".

Section 3. Authorization. The City Manager is hereby authorized to proceed with the installation of the proposed Marquee Signs as depicted on Exhibit "A".

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Cabral who moved its adoption. The motion was seconded by Vice Mayor Mariaca and upon being put to a vote, the vote was as follows:



