## RESOLUTION NO. 12-44

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO ACCEPT THE OVERWATCH TEXTRON SYSTEMS EXCELLENCE IN POLICING GRANT (EIP) FOR THE PROVISION OF THE IMPACT SOFTWARE AWARDED TO THE CITY OF DORAL; AUTHORIZING THE CITY MANAGER TO EXPEND \$2,500.00 ANNUALLY FOR THE IMPACT LICENSING FEES WHICH ARE PROVIDED AT A REDUCED FEE FOR GRANT RECIPIENTS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral has been awarded the Overwatch Textron Systems

Excellence in Police Grant (EIP) which provides the IMPACT software; and

WHEREAS, the IMPACT software is a comprehensive software solution used by Crime Analysts Units and investigators to uncover, analyze, and understand hidden connections, relationships, patterns and trends that underlie criminal and terrorist activity; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to accept the EIP Grant for the provision of the IMPACT software awarded to the City of Doral; and

WHEREAS, Staff further requests that the City Council authorize the City Manager to expend \$2,500.00 annually for the IMPACT licensing fees which are provided at a reduced fee for grant recipients.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1</u>. The City Council of the City of Doral hereby authorizes the City Manager to accept the EIP Grant for the provision of the IMPACT software awarded to the City of Doral.

Section 2. The City Council further authorizes the City Manager to expend \$2,500.00 annually for the IMPACT licensing fees which are provided at a reduced fee for grant recipients.

Section 3. This Resolution shall become effective immediately upon adoption.
