A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF DELL EMC ISILON A200 CENTRALIZED SURVEILLANCE STORAGE EQUIPMENT FOR CITYWIDE FACILITIES FROM ROUND TOWER VIA NASPO VALUEPOINT CONTRACT MNWNC-109 WITH DELL EMC. IN AN AMOUNT NOT TO EXCEED \$78,313.84; AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTUAL DOCUMENTS AND EXPEND BUDGETED FUNDS IN FURTHERANCE HEREOF; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") will be implementing a new centralized surveillance storage equipment for all city facilities; and

WHEREAS, in order to properly prepare the implementation, license, and configuration of the surveillance centralized storage equipment, the Information Technology Department has recommended the City purchase of DELL EMC Isilon A200; and

WHEREAS, the DELL EMC Isilon A200 centralized surveillance storage equipment is compatible with the City's current network infrastructure; and

WHEREAS, section 2-322 of the City Code of Ordinances provides that the City may enter into contracts competitively entered into by other governmental entities; and

WHEREAS, ROUND TOWER is a vendor participating in NASPO ValuePoint contract MNWNC-109 with Dell EMC, and ROUND TOWER has provided terms for the purchase of certain "DELL EMC Isilon A200 centralized surveillance storage equipment," as specified in the quote attached hereto as Exhibit "A" (the "Quote"), which is incorporated herein and made a part hereof by this reference; and

WHEREAS, staff has recommended the City Council purchase DELL EMC Isilon A200 centralized surveillance storage equipment from ROUND TOWER, in accordance with the quote in the amount of \$78,313.84, which has been competitively bid and is competitive even as compared to other providers selling via the NASPO ValuePoint contract, with funds payable from account #001.60005.500652.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322 of the City Code of Ordinances, the procurement of the DELL EMC Isilon A200 centralized surveillance storage equipment from ROUND TOWER., via NASPO ValuePoint contract MNWNC-109 with Dell EMC, in accordance with its quote in Exhibit "A", in an amount not to exceed \$78,313.84, is hereby approved.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the DELL EMC Isilon A200 centralized surveillance storage equipment, and to expend funds in furtherance hereof.

Section 4. Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.
