## RESOLUTION No. 19-262

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF EIGHT (8) NEW MARKED/UNMARKED POLICE VEHICLES IN AN AMOUNT NOT TO EXCEED BUDGETED FUNDS OF \$173,067.00 VIA THE AGREEMENT WITH THE STATE OF FLORIDA CONTRACT #25100000-18-1, AUTONATION CDJR PEMBROKE PINES AND GARBER CHRYSLER-DODGE TRUCK INC. VIA THE FLORIDA SHERIFF'S ASSOCIATION #FSA19-VEL27.0; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Police Department for the City of Doral (the "City") seeks to purchase eight (8) new marked/unmarked police vehicles from AutoNation CDJR Pembroke Pines via the State of Florida Contract #25100000-18-1 and Garber Chrysler-Dodge Truck Inc. via the Florida Sheriff's Association #FSA19-VEL27.0; and

WHEREAS, keeping with the past replacement strategy goals, the City of Doral Police Department recommends the purchase of eight (8) new police vehicles to replace the following: two (2) 2007 Ford Sportrac; two (2) 2008 Ford Taurus; two (2) Chevy Tahoes (2013 and 2014); one (1) 2006 Ford Expedition and one (1) 2014 Ford Interceptor with high mileage and excessive wear which will be turned over to the Public Works, Fleet Maintenance Supervisor, Marin Cevallos for possible reassignment and/or auction. The Police Department's budget for Fiscal Year 2019-2020 was approved for the purchase of seven (7) Dodge Chargers and one (1) police interceptor however, we are purchasing five (5) unmarked Dodge Chargers, one (1) marked Dodge Charger and two (2) Dodge Durangos; and

WHEREAS, section 2-322 of the City Code of Ordinances authorizes the City

to purchase good and services via the contracts of other governmental entities, provided that such contracts have been achieved in a competitive manner similar to those established in the City Code; and

WHEREAS, Staff recommends that the City Council authorize the City Manager to negotiate and enter into an agreement with AutoNation CDJR Pembroke Pines via the State of Florida Contract #25100000-18-1 for the purchase of five (5) unmarked Dodge Chargers, one (1) marked Dodge Charger and Garber Chrysler-Dodge Truck Inc. via the Florida Sheriff's Association #FSA19-VEL27.0 for the purchase of two (2) unmarked Dodge Durangos (police package) in an amount not to exceed budgeted funds of \$173,067.00, which was competitively entered into in a matter similar to that set forth in Chapter 2, Article V of the City Code; and

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322, the purchase of eight (8) new police vehicles from AutoNation CDJR Pembroke Pines via State of Florida Contract #25100000-18-1 and Garber Chrysler-Dodge Truck Inc. via the Florida Sheriff's Association #FSA19-VEL27.0 in an amount not to exceed budgeted funds of \$173,067.00 is hereby approved. This purchase is funded from the Capital Outlay-Police Vehicles account no. 001.60005.500641.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is hereby authorized to enter

into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the State of Florida contract with AutoNation CDJR Pembroke Pines and Garber Chrysler-Dodge Truck Inc. with the Florida Sheriff's Association to expend funds in furtherance thereof in an amount not to exceed budgeted funds of \$173,067.00.

<u>Section 4.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
