A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING A CHANGE OF VENDOR FROM AUTONATION CDJR PEMBROKE PINES TO GARBER FORD INC. VIA THE FLORIDA SHERIFF'S ASSOCIATION #FSA19-VEL27.0, AND A BUDGET TRANSFER FROM ACCOUNT No. 103.60005.500650 TO ACCOUNT No. 103.60005.500641 IN AN AMOUNT NOT TO EXCEED \$121,500.00 IN ORDER TO FINALIZE THE VEHICLE PURCHASE FROM APPROVED RESOLUTION No. 19-263; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Police Department's budget for Fiscal Year 2019-2020 was approved for the purchase of 13- Dodge Chargers from AutoNation CDJR Pembroke Pines via the State of Florida Contract #25100000-18-1 per Resolution No. 19-263; and

WHEREAS, the Police Dodge Pursuit Chargers originally ordered for the Police Department were cancelled by the Dodge factory along with (10) thousand orders nationwide. Due to the unavailability of the vehicles' transmissions, the factory refused to take on any new orders or give a time or date when the manufacturing would resume; and

WHEREAS, the Ford Police Interceptor (SUV) has emerged as the preferred police pursuit package, encompassing all of the safety features, essential equipment, handling and performance specifications required in a police pursuit vehicle. In addition, the Ford Taurus sedan police pursuit package is also no longer being manufactured. Therefore, the Ford Police Interceptor has become the mainstay for modern, progressive police departments and acquiring the new Ford Police Interceptor will allow continuity to

the existing police fleet.

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to the following:

- change of vendor in order to finalize the purchase approved from Resolution No.
 19-263 of the new marked police vehicles with Garber Ford Inc. via the Florida
 Sheriff's Association # FSA19-VEL27.0 in an amount not to exceed budgeted funds; and
- a budget transfer from GL Account #103.60005.500650-Police Impact Fees-Construction in Progress to GL Account #103.60005.500641- Police Impact Fees-Capital Outlay Vehicles in an amount not to exceed budgeted funds of \$121,500.00 for the retrofitting of the mentioned marked police vehicles per Resolution No. 19-263.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The City Manager hereby approves the change of vendor in order to finalize the purchase approved from Resolution No. 19-263 and the budget transfer from GL Account #103.60005.500650-Police Impact Fees-Construction in Progress to GL Account #103.60005.500641- Police Impact Fees- Capital Outlay Vehicles for a total not to exceed budgeted funds in the amount of \$121,500.00.

Section 3. Authorization. The City Manager is hereby authorized to

transfer the funds and to execute the Agreement and expend budgeted funds on behalf of the City.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.
