## **RESOLUTION No. 15-65**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY CODE OF ORDINANCES, APPROVING THE PURCHASE OF (21) POLICE VEHICLES AND DECALING BY L.S. SIGNS (\$9,500.00) IN AN AMOUNT NOT TO EXCEED \$668,419.50 VIA THE AGREEMENT WITH THE FLEET SHERIFF'S ASSOCIATION AND DON REID FORD; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT, SUBJECT TO APPROVAL AS TO FORM AND LEGAL SUFFICIENCY BY THE CITY ATTORNEY, FOR THE PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department seeks to purchase 21 vehicles from Don Reid Ford as follows: (3) School Resource Unit, (2) K-9 Unit, (14) Uniform Patrol and (2) Command Staff (Uniform Patrol Lieutenant's) (the "Vehciles"); and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to negotiate and enter into an agreement with Don Reid Ford for the purchase of 21 police vehicles and decaling by L.S. Signs (\$9,500.00) in an amount not to exceed \$668,419.50 via Don Reid Ford and the Fleet Sheriff's Association which was competitively entered into in a manner similar to that set forth in Chapter 2, Article V of the City Code.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

**Section 1.** Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part of this reference.

**Section 2.** Approval. The procurement of the Vehicles and decaling by L.S.

Signs (\$9,500.00) in an amount not to exceed \$668,419.50 via the Fleet Sheriff's Association agreement with Don Reid Ford is hereby approved pursuant to Section 2-322 of the City Code of Ordinance.

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement and other contractual documents, subject to approval as to form and legal sufficiency by the City Attorney, as may be necessary to procure the Vehicles under the Fleet Sheriff's Association Agreement with Don Reid, and to expend funds in furtherance thereof in amounts not to exceed \$668,419.50.00.

**Section 4. Implementation.** The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
