A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO AMEND WORK ORDER NO. 3 WITH BCC ENGINEERING TO INCLUDE THE DESIGN OF THE TRAFFIC SIGNALS AT THE NW 74 STREET / NW 102 AVENUE AND NW 74 STREET / NW 97 AVENUE INTERSECTIONS, IN AN AMOUNT OF \$37,179.43, FOR A TOTAL NOT TO EXCEED AMOUNT OF \$177,020.40; AUTHORIZING THE CITY MANAGER TO EXECUTE THE WORK ORDER AMENDMENT WITH BCC ENGINEERING AND EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral (the "City") is presently engaged in the design of a new roadway connection along NW 102nd Avenue between NW 66th Street and NW 74th; and

WHEREAS, the City will be responsible for 100% of the design and construction costs of the road on NW 102 Avenue between NW 74 Street and NW 66 Street; and

WHEREAS, Miami-Dade County has performed a signal warrant analysis and has acknowledged a need to include a traffic signal devices at that intersection of NW 74 Street and NW 102 Avenue and another one at the intersection of NW 74 Street and NW 97 Avenue; and

WHEREAS, the traffic signal to be placed at NW 74 Street and NW 97 Avenue lies in the intersection of two (2) county roads; and

WHEREAS, the traffic signal to be placed at NW 74 Street and NW 102 Avenue lies in the intersection of one (1) county road and one (1) City road;

WHEREAS, the City is presently contracted with BCC Engineering for the design of a new roadway connection along NW 102 Avenue between NW 74 Street and NW 66

Street and find that it would be cost effective to employ the services of BCC Engineering to also undertake the design of the traffic signals at the intersection of NW 74 Street and NW 97 Avenue and at the intersection of NW 74 Street and NW 102 Avenue; and

WHEREAS, Staff has recommended that the City Council authorize the City Manager to amend work order no. 3 with BCC Engineering to incorporate the design of the traffic signals into the going design of the new roadway connection along NW 102 Avenue (74 St. – 66 St.) in an amount of \$37,179.43 for a total not to exceed amount of \$177,020.40. Funding will be from Account # 101.80005.500650

.NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval. The work order amendment with BCC Engineering to incorporate the design of the traffic signals along NW 74 Street at the intersections of NW 102 and NW 97 Avenue into the going design of the new roadway connection along NW 102 Avenue (74 St. – 66 St.) in an amount of \$37,179.43 for a total not to exceed amount of \$177,020.40, a copy which is attached hereto as Exhibit "A" and incorporated herein and made part hereof by this reference, is hereby approved.

<u>Section 3.</u> <u>Authorization.</u> The City Manager is authorized to execute the work order amendment with BCC Engineering and expend budgeted funds on the behalf of the City in furtherance hereof.

FIRST AMENDMENT TO WORK ORDER NO. 3 BETWEEN THE CITY OF DORAL, FLORIDA AND BCC ENGINEERING, INC.

This First Amendment to BCC's Work Order No. 3 made and entered into this <u>13</u> day of <u>June</u>, <u>2017</u>, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and BCC. ("Consultant") having its place of business at 6401 S.W 87th Avenue Miami, FL 33143, for the provision of Design Services for Traffic Signal Improvements Project along NW 74 Street at the Intersections of NW 102 Avenue and NW 97 Avenue.

WHEREAS, the City of Doral is presently engaged in the design of a new roadway connection along NW 102nd Avenue between NW 66th Street and NW 74th; and

WHEREAS, Miami-Dade County has performed a signal warrant analysis and has acknowledged a need to include a traffic signal devices at that intersection of NW 74 Street and NW 102 Avenue and another one at the intersection of NW 74 Street and NW 97 Avenue; and

WHEREAS, the City of Doral is presently contracted with BCC Engineering for the design of a new roadway connection along NW 102 Avenue between NW 74 Street and NW 66 Street and find that it would be cost effective to employ the services of BCC Engineering to also undertake the design of the traffic signals at the intersection of NW 74 Street and NW 97 Avenue and at the intersection of NW 74 Street and NW 102 Avenue; and

WHEREAS, the original cost for the design services for the new roadway connection along NW 102 Avenue between NW 74 Street and NW 66 Street approved by the Work Order was a not to exceed amount of \$139,840.97; and

WHEREAS, the cost for the provision of design services was increased to a not exceed amount of \$177,020.40 for the addition of the design services for the traffic signal improvements, with the cost of the amended work to be a not to exceed amount of \$37,179.43.

NOW THEREFORE, in consideration of the mutual covenants set forth in this First Amendment, the parties agree as follows:

Section 1. Recitals. The above recitals are true and correct and incorporated herein.

Section 2. Amendments. The following Sections of the Work Order are hereby amended to read as follows:

"SCOPE OF SERVICES AND SCHEDULE:

...The performance of services associated with this Work Order will be executed on a time and material basis with a not to exceed amount of \$139,840.97 \$177,020.40."

EXCEPT AS PROVIDED HEREIN, all other terms and conditions of the Contract dated January 13, 2016, remain in full force and effect.
