## **RESOLUTION No. 07 – 02**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPROVE A CHANGE ORDER FOR PHASE II OF CONSTRUCTION IN DORAL MEADOW PARK WITH RECREATIONAL DESIGN & CONSTRUCTION, INC. IN THE AMOUNT OF \$33,265.00 FOR THE INSTALLATION OF LOGOS ON THE ARTIFICIAL FOOTBALL FIELD AT DORAL MEADOW PARK; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral intends to provide its residents with the highest quality park and recreational facilities at Doral Meadow Park; and

WHEREAS, Resolution #06-36 authorized the City Manager to negotiate and enter into an agreement with Recreational Design and Construction, Inc. (RDC) for build and design services for Phase II construction of Doral Meadow Park; and

WHEREAS, Staff respectfully recommends that the City Council of the City of Doral authorize the City Manager to approve a change order for Phase II of construction in Doral Meadow Park with RDC in the amount of \$33,265.00 for the installation of logos on the artificial football field at Doral Meadow Park.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral Florida hereby authorizes the City Manager to approve a change order for Phase II of construction with RDC in the amount of \$33,265.00 plus an additional \$7,981.00 consistent with Option #4 as presented during the January 10, 2007 City of Doral Council Meeting for a total of \$44,348.00 for the installation of logos on the artificial football field at Doral Meadow Park as follows:

- 1. City of Doral logo in the center of the field.
- 2. Blue end zones with gold letters spelling "DORAL."
- 3. Alternating green panels

Section 2. This Resolution shall take effect immediately upon adoption.
