A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, ADOPTING THE PARKS AND RECREATION FEE SCHEDULE; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Parks and Recreation Department has reviewed the Fee Schedule of the County and various municipalities for picnic and party rentals and field use; and

WHEREAS, a policy and permit procedure would regulate parties and ensure that rentals do not negatively impact neighboring residents.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council hereby establishes the parks and recreation fee schedule included in Exhibit "A."

<u>Section 2.</u> This Resolution shall become effective immediately upon its adoption.

EXHIBIT "A"

Party and Field Rental Fee Schedule

The City of Doral has picnic tables available for rent at Doral Park and Miami West Park. There are a total of 8 picnic tables at Doral Park and 60 picnic tables available at Miami West Park. The Parks and Recreation Department will limit the number and location of tables to be rented in order to minimize conflict and maintain available space.

Recommended Fee for Picnic Table Rental

Deposit:

\$25.00

Rental Fee:

Residents: \$75.00 + tax

Non-Residents of incorporated areas \$100.00 + tax

** A \$25.00 Refundable Cash Deposit and the Rental Fee is required upon signing of the Agreement. The deposit will be refunded upon prior notice of cancellation, at least (2) weeks in advance, or verification that all trash has been removed. Reservations may be made for any period of time that the facility is available, but not more than one year in advance. No refunds will be made unless written notice is received for cancellation at least two (2) weeks in advance. All cancellations will be subject to a service fee of \$25.00 or 50% if cancelled 14 calendar days or less prior to the event.

Individuals interested in renting a picnic table will be required to fill out a Facility Use Permit Application with payment, at the Parks and Recreation Department in City Hall. All fees and City of Doral Rules and Regulations must be followed and are subject to change.

Upon completing the Facility Use Permit application, the applicant will receive a reservation receipt and a copy of the selected park's site map indicating the designated location of the party set-up and picnic table. The number of parking spaces and total number of individuals attending the party in each park will be considered when making reservations. Parties that exceed the number of guests submitted on the application may result in revocation of permit and cancellation of the party.

Applicants interested in having any special equipment such as bounce houses, tents, tarps, amusement games, or mechanical rides on City of Doral Park, will be required to complete a Facility Use-Special Request Form. Upon approval from the Director of Parks and Recreation, and a minimum of two (2) weeks prior to rental, the applicant must provide the City with a Certificate of Insurance naming the City of Doral as "Additional Insured".

Any individual and/or organization, that is not under contract with the City of Doral and is interested in renting a field, will be required to complete a Facility Use Permit Application.
