A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, WAIVING THE COMPETITIVE BID PROCESS PURSUANT TO SECTION 2-321 OF THE CITY'S CODE OF ORDINANCES AND AUTHORIZING THE CITY MANAGER TO EXTEND THE EXISTING AGREEMENT WITH DORAL FENCING CLUB FOR THE PROVISION OF FENCING PROGRAMMING FOR THE CITY OF DORAL PARKS AND RECREATION DEPARTMENT FOR A PERIOD OF SIX (6) MONTHS THROUGH SEPTEMBER 2020; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Doral Fencing Club is a unique and successful program currently offered in our parks. Doral Fencing Club began offering programing at Doral Legacy Park in April 2019 and provides another sport option outside of the traditional sports for both boys and girls; and

WHEREAS, the program practices three-four times a week and pays the City 25% of all registration fees collected on a monthly basis; and

WHEREAS, the current agreement with Doral Fencing Club is set to expire at the end of March 2020; and

WHEREAS, Staff respectfully requests Mayor and City Council-members approval to waive the competitive bid process as pursuant to section 2-321 of the City Code of Ordinances and authorize the City Manager to extend the existing agreement with Doral Fencing Club for the provision of providing fencing program for the City of Doral Parks and Recreation Department for a period of six (6) months through September 2020.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> <u>Recitals.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.
