## **RESOLUTION No. 07-44**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA; ESTABLISHING A PROPOSED MILLAGE RATE OF 2.447 TO BALANCE THE GENERAL FUND FOR FISCAL YEAR 2007-2008, ESTABLISHING THE CURRENT YEAR ROLLED-BACK RATE TO BE 2.136 AND ESTABLISHING THE FIRST AND SECOND PUBLIC BUDGET HEARINGS AS REQUIRED BY LAW; DIRECTING THE CLERK AND MANAGER TO FILE SAID RESOLUTION WITH THE PROPERTY APPRAISER OF MIAMI-DADE COUNTY PURSUANT TO THE REQUIREMENTS OF FLORIDA STATUTES AND THE RULES AND REGULATIONS OF THE DEPARTMENT OF REVENUE AND THE STATE OF FLORIDA; ESTABLISHING THE TIME AND LOCATION OF THE FIRST AND SECOND PUBLIC HEARINGS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on July 1, 2007, the Honorable Marcus L. Saiz de la Mora, Acting
Property Appraiser of Miami-Dade County, Florida served upon the City of Doral a

"Certification of Taxable Value" certifying to the City of Doral its 2006 taxable value; and

WHEREAS, the provisions of Florida Statues Section 200.065 require that within thirty five (35) days of service of the Certification of Taxable Value upon a municipality, said municipality shall be required to furnish to the Property Appraiser of Miami-Dade County the proposed millage rate, the current year roll back rate, and the date, time and place at which a first public hearing will be held to consider the proposed millage rate and tentative budget; and

WHEREAS, The City Council desires to announce the dates of the first and second hearings to the Property Appraiser of Miami-Dade County; and

WHEREAS, The City Council has reviewed the figures supplied by the Property

Appraiser of Miami-Dade County and that being otherwise fully advised in the premises;

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AS FOLLOWS:

<u>Section 1</u>. That the proposed millage for the first public hearing is hereby declared to be <u>2.447</u> mills which is <u>\$2.447</u> per \$1,000.00 of assessed property within the City of Doral.

Section 2. That the City Council further confirms the current year rolled back rate computed pursuant to section 200.065 F.S., is <u>2.136</u> mills which is <u>\$2.136</u> per \$1,000.00 of assessed property within the City of Doral.

<u>Section 3.</u> That the date, time and place of the first and second public hearings are hereby set by the City Council as follows:

Section 5. This Resolution shall be effectively immediately upon adoption.
