A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO TERMINATE THE EXISTING AGREEMENT WITH CLEAR WHICH CURRENTLY PROVIDES AN INVESTIGATIVE DATABASE: AUTHORIZING THE CITY MANAGER NEGOTIATE AND ENTER INTO AN AGREEMENT WITH LEADSONLINE TOTALTRACK **PLUS** METAL THEFT INVESTIGATION SYSTEM FOR THE PROVISION OF AN **INVESTIGATIVE DATABASE IN THE AMOUNT OF \$6,188.00 PER** YEAR FOR A PERIOD OF THREE (3) YEARS BASED ON THIS VENDOR'S STATUS AS A SOLE SOURCE PROVIDER OF SAID SERVICES: AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral Police Department seeks to purchase the LeadsOnline TotalTrack Plus Metal Theft Investigation System (LeadsOnLine), a secured web-based system for the automated collection and analysis of transaction records from pawn shops, second-hand dealers, game stores, etc.; and

WHEREAS, the City has an existing agreement with CLEAR for investigative database services at a cost of approximately \$12,000.00 per year and the City has recently obtained access to a similar and more advanced database called TLO which was offered to the City free of charge; and

WHEREAS, Staff respectfully requests that the City Council authorize the City Manager to terminate the existing agreement with CLEAR which currently provides for an investigative database being that the TLO system is currently being used successfully; and

WHEREAS, Staff further requests that the City Council authorize the City Manager to negotiate and enter into an agreement with LeadsOnLine for the provision of an investigative database in the amount of \$6,188.00 per year for a period of three (3) years based on this vendor's status as a sole source provider; and recognize that all procedures detailed in Section 287.057, F.S. have been followed.
