A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AWARDING REQUEST FOR PROPOSALS #2019-26 "IMPROVEMENTS TO BALL FIELDS" TO THE TOP RANKED FIRM, AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH TEAM CONTRACTING, INC. FOR THE PROVISION OF PERFORMING IMPROVEMENTS TO THE BALL FIELDS AT DORAL MEADOW PARK, FOR AN AMOUNT NOT TO EXCEED \$137,350.00 PLUS A 10% CONTINGENCY FOR A TOTAL NOT TO EXCEED AMOUNT OF \$151,085.00.; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, On June 26, 2019, the City advertised Request for Proposals # 2019-26 "Improvements to Ball Fields" for the provision of performing improvements to the ball fields at Doral Legacy Park and Doral Meadow Park to include the design and construction of new barrier netting and fencing; and

WHEREAS, Seven (7) firms attended the mandatory pre-bid meeting on July 9, 2019. One (1) submittal was received and opened on July 25, 2019, with that firm meeting the required criteria set forth in the Request for Proposals; and

WHEREAS, On October 10, 2019, the evaluation committee scored and ranked the submittal based on a three-hundred point (300) scale.

WHEREAS, Due to the pending completion of remedial work on the baseball field at Doral Legacy Park and the time needed to monitor the work after completion, administration and staff felt it would be best to remove the scope of work for Doral Legacy Park as part of this solicitation and proceed to award only the work which pertains to Doral Meadow Park; and

WHEREAS, Staff respectfully requests City Council approval to authorize the City Manager to negotiate and enter into an agreement with Team Contracting, Inc. for the

provision of performing improvements to the ball field at Doral Meadow Park to include the design and construction of new barrier netting and fencing for a not to exceed amount of \$137,350.00 plus a 10% contingency for a total not to exceed amount of \$151,085.00

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

Section 2. Approval & Authorization. The City Council hereby approves the award of RFP # 2019-26 to the top ranked firm and authorizes the City Manager to negotiate and enter into an agreement with Team Contracting, Inc. for the provision of performing improvements to the ball field at Doral Meadow Park to include the design and construction of new barrier netting and fencing for a not to exceed amount of \$137,350.00 plus a 10% contingency for a total not to exceed amount of \$151,085.00. The agreement is subject to approval by the City Attorney as to form and legal sufficiency and on such other terms and conditions as may be appropriate to protect and further the interest of the City. This Authorization does not create or confer any rights to Team Contracting, Inc. Funds for this project will come from account #102.90005.500634.

<u>Section 3.</u> <u>Implementation.</u> The City Manager and the City Attorney are hereby authorized to take such action as may be necessary to implement the provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This resolution shall take effect immediately upon adoption.
