A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA WAIVING THE REQUEST FOR PROPOSALS PROCESS AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH SUPER LANDSCAPE AND MAINTENANCE, INC. FOR THE PROVISION OF LANDSCAPE MAINTENANCE SERVICES AT DORAL PARK AND J.C. BERMUDEZ PARK; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of Doral seeks to provide the highest quality parks for the enjoyment and benefit of its residents; and

WHEREAS, in 2004, after a competitive bidding process, the City of Doral contracted with Superior Landscaping and U.S. Lawn, Inc. for parks maintenance services; and

WHEREAS, due to very poor performance, the City terminated the contracts with both vendors; and

WHEREAS, Super Landscape & Maintenance, Inc. has been providing landscape and maintenance services at Doral Park and J.C. Bermudez Park for the past several months at a very competitive price; and

WHEREAS, because of the highly satisfactory work that has thus far been performed by this current vendor, Staff respectfully requests the following:

Council waiver of the RFP process and authorization of the City Manager
to negotiate and enter into an agreement with Super Landscape &
Maintenance, Inc. for landscape services at Doral Park and J.C.
 Bermudez Park.

 Council approval of a contractual amount of \$168,984.00 which will allow for a total of 36 cuts throughout the year.

Council approval of an extension of contract for a maximum of five (5),
 one-year terms should pricing and service remain consistent.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:

<u>Section 1</u>. The City Council of the City of Doral, Florida hereby waives the RFP process and authorizes the City Manager to negotiate and enter into an agreement with Super Landscape & Maintenance, Inc. for the provision of landscape and maintenance services at Doral Park and J.C. Bermudez Park and approves the Staff requests as listed in the above "whereas" clause.

<u>Section 2.</u> This Resolution shall become effective upon its passage and adoption by the City Council.
