RESOLUTION NO. 04-14

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN **AGREEMENT** BY AND **BETWEEN** MIAMI-DADE COUNTY, FLORIDA AND THE CITY OF DORAL FOR SPECIALIZED POLICE SERVICES; REQUESTING MIAMI-**DADE** COUNTY TO **EXPEDITE** THE **APPROVAL PROCESS: PROVIDING FOR AUTHORIZATION:** PROVIDING FOR TRANSMITTAL; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 9.3 of the City of Doral (the "City") Charter requires that the City enter into a contract with Miami-Dade County (the "County") for specialized law enforcement services.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Approval. The attached Agreement by and between the County and the City for specialized police services (the "Agreement") is hereby approved.

Section 3. Approval Process. The City hereby request that:

- 3.1 The County's Public Safety Committee (the "Committee") approves the Agreement and if approved that the Committee's Chairperson place the matter on an agenda for the next available County Commission meeting in March.
- 3.2 The Chairperson of the County Commission waive the one month requirement for forwarding the Agreement for consideration by the County Commission.

Section 4. Authorization. The Mayor is hereby authorized to execute the Agreement

on behalf of the City.

Section 5. Transmittal. The Clerk is hereby authorized to transmit certified copies of this Resolution to all appropriate County personnel.

Section 6. Effective Date. This Resolution shall become effective immediately upon its adoption.

The foregoing Resolution was offered by Councilwoman Ruiz, who moved its adoption.
