## **RESOLUTION No. 15-51**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING A SPONSORSHIP OF PFC BRUCE W. CARTER, YOUNG MARINES PROGRAM IN THE AMOUNT OF \$2,500.00; AUTHORIZING THE CITY MANAGER TO EXPEND FUNDS AND EXECUTE SPONSORSHIP DOCUMENTS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Pfc. Bruce W. Carter Young Marines (the "Young Marines") is a nationally-renowned, community-based program led by dedicated, volunteer former, retired, activity duty, or reserve members of the United States Marines; and

WHEREAS, the Young Marines promotes mental, moral and physical development of its members, which includes children from diverse communities, as well as, character building, leadership and supports a healthy drug free life style; and

WHEREAS, as home of United States Southern Command, the City of Doral (the "City") enjoys a special relationship with the United States military, one which it would like to further by supporting the Young Marines for the benefit of the youth in the City; and

WHEREAS, Staff has recommended that the Mayor and City Council authorize the City Manager to support and sponsor the Young Marines in the amount of \$2,500.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

**Section 1.** Recitals. The foregoing recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

**Section 2.** Approval. A sponsorship in the amount of \$2,500.00 for the benefit of the Young Marines is hereby approved. The City Manager is hereby

approved to expend City funds in furtherance of this sponsorship and to execute an agreement or other appropriate documentation as may be necessary to formalize the sponsorship with the Young Marines, subject to approval as to form and legal sufficiency by the City Attorney.

**Section 3.** Implementation. The City Manager and City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

**Section 4.** This Resolution shall become effective immediately upon its adoption.
