## **RESOLUTION No. 20-15**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, URGING THE STATE LEGISLATURE TO ENACT LEGISLATION TO FURTHER REGULATE HOMEOWNERS ASSOCIATIONS; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS**, in 2018, the State of Florida proposed the "Homeowners' Associations", legislation prohibiting associations from hiring an attorney who represents management company of associations; and

WHEREAS, on February 13, 2019, the city of Doral passed a Resolution number 19-48 urging the Florida Legislature to adopt legislation enacting a review of Homeowners" Association; and

**WHEREAS**, an estimated two (2) million homes are currently managed by some form of Homeowners Association in Florida; and

WHEREAS, the City of Doral has over 150 communities which are managed by Homeowner/Condo Associations; and

**WHEREAS**, when HOA's do not function as planned, homeowners pay a heavy toll in court, fines, liens and foreclosures; and

**WHEREAS**, more oversight, government regulations, mandatory training for volunteer associations boards, background check and financial accountability need to be put in place to ensure that HOA's are managed effectively; and

**WHEREAS**, the City of Doral supports the passage of legislation that requires greater transparency in governance and the handling of day-to-day business.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL
