## RESOLUTION No. 19-299

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING AN AMENDMENT TO MODIFY THE AMENDED AND RESTATED MASTER DEVELOPMENT AGREEMENT FOR DOWNTOWN DORAL SOUTH; PROVIDING FOR RECORDATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, CC-WCD TIC, LLC and White Course Lennar, LLC (the "Developers") owners of certain lands, commonly known as Downtown Doral South entered into an Amended and Restated Master Development Agreement for Downtown Doral South with the City of Doral on November 2, 2018; and

WHEREAS, the Amended and Restated Master Development Agreement incorporated the approvals of the amended and restated pattern book that illustrated scope, planned uses, design and appearance of the Project; and

WHEREAS, pursuant to the paragraph 13(b)(ii)-Cultural Affairs Contribution of the Amended and Restated Master Development Agreement, Developers have contributed five hundred thousand dollars (\$500,000.00) to the preparation of plans for the improvement of the cultural arts pavilion to be located in the Triangle parcel in Downtown Doral; and

WHEREAS, paragraph 13(b)(ii) also provides that Developers will also contribute one million dollars (\$1,000,000.00) for the construction of the cultural arts pavilion; and

WHEREAS, on November 6, 2018, the General Obligation Parks Bond for \$150 million was passed in order to help fund the construction of high-priority park projects which included the cultural arts pavilion; and

WHEREAS, since the construction of cultural arts pavilion will be funded by the

General Obligation Bond, the City after careful review and deliberation, has determined that the reallocation of the Cultural Arts Contribution towards the acquisition of public art will further enhance the cultural arts pavilion project; promote the general welfare of the community, make a significant contribution towards creating a cultural legacy for future generations in Downtown Doral South through the collection and exhibition of high-quality art pieces.

WHEREAS, public art exhibited around the cultural arts pavilion and in Downtown Doral South will enhance our civic spaces, and add a uniqueness to our community; and

WHEREAS, the City Council finds that the proposed modification to the Amended and Restated Master Development Agreement is in the best interest and welfare of the residents of the City of Doral.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are true, correct, and incorporated herein by this reference.

**Section 2.** Approval. The Mayor and City Council of the City of Doral hereby Approves the First Amendment to Amended and Restated Master Development Agreement (attached as Exhibit "A").

**Section 3. Authorization.** The Mayor and City Council of the City of Doral hereby authorize the City Manager to execute the First Amendment to Amended and Restated Master Development Agreement on behalf of the City in furtherance hereof.

The City Manager is further authorized to take the necessary actions including but not limited to negotiating and entering into an additional agreement(s) to further the purpose of the First Amendment to Amended and Restated Master Development Agreement and legislative intent expressed in the recitals contained in this resolution.

Section 4. Recordation. This Resolution and First Amendment to Amended and Restated Master Development Agreement shall be recorded in the Public Records of Miami-Dade County, Florida.

<u>Section</u> <u>5.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon adoption.
