## **RESOLUTION No. 15-233**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, APPROVING A MUTUAL AID AGREEMENT BETWEEN THE SOUTH **FLORIDA** INTENSITY DRUG TRAFFICKING AREA AND THE CITY OF ALLOW **FOR** COOPERATION DORAL TO **FOR** DISMANTLING AND DISRUPTION OF THE OPERATIONS OF TRAFFICKING ORGANIZATIONS: PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the South Florida High Intensity Drug Trafficking Area ("HIDTA") and the City of Doral (the "City") individually have the authority to investigate and law enforcement activities for the purpose of dismantle and disrupt the operations of drug trafficking organizations; and

WHEREAS, the City desires to participate in the HIDTA so as to participate in the associated strike force and cooperatively participate in the investigation of money laundering, drug trafficking, and/or related crimes; and

WHEREAS, Staff has recommended that the City Council approve a Mutual Aid Agreement between the HIDTA and the City for the purposes stated.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made a part hereof by this reference.

<u>Section 2.</u> <u>Approval & Authorization.</u> The Mutual Aid Agreement between the South Florida High Intensity Drug Trafficking Area and the City of Doral, attached hereto as Exhibit "A", which is incorporated herein and made a part hereof by this reference, is hereby approved. The City Manager is hereby authorized to execute

the Mutual Aid Agreement on behalf of the City, subject to approval by the City Attorney as to form and legal sufficiency.

Section 3. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and provisions of this Resolution.

<u>Section 4.</u> <u>Effective Date.</u> This Resolution shall become effective immediately upon its adoption.
