A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CITY'S CODE OF ORDINANCES, APPROVING THE PURCHASE OF ONE (1) 2020 NISSAN LEAF S FOR THE PUBLIC WORKS DEPARTMENT; PURSUANT TO THE EXISTING AGREEMENT BETWEEN WESTON NISSAN AND THE FLORIDA SHERIFFS ASSOCIATION, WHICH WAS COMPETITIVELY ENTERED INTO IN A MANNER SIMILAR TO THAT SET FORTH IN CHAPTER 2, ARTICLE V, OF THE CITY CODE; AUTHORIZING THE CITY MANAGER TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN AN AMOUNT NOT TO EXCEED \$25,536.00; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Public Works Department (PWD) respectfully requests authorization from the Mayor and the City Council-Members to purchase a Zero-Emission 2020 Nissan Leaf S; and

WHEREAS, the 2020 Nissan Leaf S has a Battery charge range of 150 miles per charge, enough power to cover all city daily demands; and

WHEREAS, funds were identified from the Public Works Transportation Fund "Capital Outlay – Vehicles" Account No. 101.80005.500641; and

WHEREAS, the funds are sufficient to cover the cost of \$25,536.00 for the purchase of previously mentioned vehicle; and

WHEREAS, pursuant to section 2-322 of the City Code, Weston Nissan holds Contract No. FSA19-VEL27.0 with the Florida Sheriffs Association Contract, which was competitively entered into a manner similar to that set forth in Chapter 2, Article V, of the City of Doral code of ordinances, a copy of which is attached as part of Exhibit "A", which provides the best price for a 2020 Nissan Leaf S.

NOW, THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

<u>Section 1.</u> Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. The Mayor and the City Council Members of the City of Doral hereby authorizes the City Manager to purchase a 2020 Nissan Leaf S from the funds identified in the current Fiscal Year in the Transportation Fund "Capital Outlay – Vehicles" Account No. 101.80005.500641, in an amount not to exceed \$25,536.00.

<u>Section 3.</u> <u>Authorization.</u> The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 4. Authorization. The City Manager is authorized to execute the purchase agreement and expend budgeted funds on the behalf of the City.

<u>Section 5.</u> <u>Effective Date.</u> This Resolution shall take effect immediately upon adoption.
