This Agreement ("Agreement") made up this 1st day of <u>October2019</u>, by and between the City of Doral, Florida, a municipal corporation of the State of Florida ("City") and Pradere Manufacturing Corp. ("Contractor") having its place of business at 7655 W 20 Ave Hialeah FL, 33014, for the provision of office furniture and Files for City Facilities on as needed basis.

WHEREAS, Krug Inc. has an active agreement with the State of Florida (State Term Contract No. 425-001-12-1), dated March 02, 2012, which was competitively entered into in a manner consistent with Chapter 2 of the City Code; and

WHEREAS, on September 11, 2019 the Mayor and the City Council members adopted Resolution No. 19-230 authorizing the City Manager to adopt and to enter into an agreement with approved manufacturers, Manufacturer's representatives, and any additional manufacturer that may be added to the pool, for the provision of office furniture and files for City Facilities on as needed basis, based on the State of Florida Office Furniture and Files contract with Krug Inc., for an initial period of four (4) year period, from March 2, 2012 to March 1, 2016. The contract was renewed on March 1, 2016 for an additional four (4) year period with an expiration date on March 1,2020; and

WHEREAS, Pradere Manufacturing Corp is an authorized manufacturer representative under State Term Contract No. 425-001-12-1.

NOW THEREFORE, in consideration of the mutual covenants set forth in this Agreement, the parties agree as follows:

- Section 1. Recitals. The above recitals are true and correct and incorporated herein.
- Section 2. Agreement. The City of Doral and Pradere Manufacturing Corp., agree to enter into a contract agreement for the provision of office furniture and files for the City Facilities, State Contract No. 425-001-12-1. The agreement shall expire on the same date as the State Contract No. 425-001-12-1.

All other terms, pricing and conditions are subject to State of Florida, State Term Contract No. 44102100-17-1 and specifically incorporated into this Agreement.

WHEREAS, currently the City has been purchasing office furniture from different suppliers on an as needed basis at retail price; and

WHEREAS, the intent of adopting this contract is to obtain better pricing and to expand the list of approved manufacturers and suppliers available to the City; and

WHEREAS, the state term contract includes for the purchase of office and conference/public area furniture, including lateral and vertical steel files, dispatch/911 furniture, conference or training tables, mail processing furniture, conference or training chairs, map files, storage and presentation accessories, reception desks, single and multiple seating units, sofas and loveseats (public areas), and occasional tables. Fireproof files, art work and decorative lamps and accessories are not part of this contract; and

Funds for these services were budgeted in the current fiscal year in the General Fund Account Number 001.80005.500520 – Operating Supplies, 001.80005.500640 – Capital Outlay, and in the Public Works CIP Fund Account Number 301.80005.500640 – Capital Outlay Office.
