

RESOLUTION No. 17-146

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, PURSUANT TO SECTION 2-322 OF THE CODE OF ORDINANCES, APPROVING THE PROCUREMENT OF ONE (1) FORD F-150 PICKUP TRUCK AND ONE (1) FORD F-550 DUMP TRUCK FOR THE PUBLIC WORKS DEPARTMENT, VIA FLORIDA SHERIFFS ASSOCIATION CONTRACT #FSA16-VEH14.0 WITH DUVAL FORD FOR A TOTAL AMOUNT NOT TO EXCEED \$85,765.66, AND ONE (1) JOHN DEER 318G SKID STEER LOADER FOR THE PUBLIC WORKS DEPARTMENT, VIA FLORIDA STATE CONTRACT #25100000-16-1 WITH NORTRAX FORD FOR A TOTAL AMOUNT NOT TO EXCEED \$55,459.00; AUTHORIZING THE CITY MANAGER TO EXECUTE CONTROL DOCUMENTS AND TO EXPEND BUDGETED FUNDS ON BEHALF OF THE CITY IN AN AMOUNT NOT TO EXCEED \$141,224.66 IN FURTHERANCE HEREOF; APPROVING A BUDGET TRANSFER OF \$141,224.66 FROM PUBLIC WORKS ACCOUNT NO. 001.80005.500633 (IMPROVEMENTS - STREETS) TO PUBLIC WORKS ACCOUNT NO. 001.80005.500641 (CAPITAL OUTLAY - VEHICLES); PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as a result of the City of Doral's (the "City") growth, the construction of new City Facilities, and the City's primary goal to provide better services to the community, the Public Works Department seeks to purchase one Ford F-150 pickup truck for the Facility Maintenance Division, one Ford F-550 dump truck for the Right-of-Way Maintenance Division, and one John Deer skid steer loader for the Right-of-Way Maintenance Division; and

WHEREAS, staff performed research to obtain the best possible prices for the purchase of the vehicles; and

WHEREAS, section 2-322 of the City Code of Ordinances provides that the City is authorized to enter into bids or contracts entered into by other governmental authorities provided that the governmental authority has followed a competitive bidding

procedure leading to the award of the bid or contract in question which is substantially similar to the City's competitive bidding procedure ("Procurement Code"); and

WHEREAS, Duval Ford holds Contract No. FSA16-VEH14.0 with the Florida Sheriffs Association, attached as part of Exhibit "A", which was competitively entered into a manner similar to provisions of the City's Procurement Code, and it provides the best prices for the Ford F-150 pickup truck (\$26,533.80) and the Ford F-550 dump truck (\$59,231.86); and

WHEREAS, NORTRAX holds Contract No. 25100000-16-1 with the State of Florida, attached as part of Exhibit "A", which was competitively entered into a manner similar to provisions of the City's Procurement Code, which provides the best price for the John Deer 318G skid steer loader (\$55,459.00); and

WHEREAS, savings were identified in the current Fiscal Year in the Public Works "Improvements – Streets" Account (Account No. 001.80005.500633) as a result of the NW 54 Street (87 – 79 Avenue) project coming in \$498,406.01 below budget; and

WHEREAS, staff has recommended that the City Council authorize a budget transfer of \$141,224.66 from Public Works "Improvements – Streets" (Account No. 001.80005.500633) to the Public Works "Capital Outlay – Vehicles" (Account No. 001.80005.500641) for the purchase of the vehicles; and

WHEREAS, staff further requests that the City Council authorize the City Manager to enter into an agreement with Duval Ford for the purchase of one Ford F-150 pickup truck and one Ford F-550 dump truck in a total amount not to exceed

\$85,765.66, and to enter into an agreement with NORTRAX for the purchase of one John Deer 318G skid steer loader in a total amount not to exceed \$55,459.00.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF DORAL AS FOLLOWS:

Section 1. Recitals. The above recitals are confirmed, adopted, and incorporated herein and made part hereof by this reference.

Section 2. Approval. Pursuant to section 2-322 of the City Code of Ordinances, the purchase of one (1) Ford F-150 pickup truck, in the amount of \$26,533.80, and one (1) Ford F-550 Landscape Dump Truck in the amount of \$59,231.86 from Duval Ford, via Florida Sheriffs Association Contract No. FSA16-VEH14.0, attached hereto as Composite Exhibit "A", and the purchase one (1) John Deer 318G Skid Steer Loader, in the amount of \$55,459.00, from NORTRAX, via Florida State Contract No. 25100000-16-1, are hereby approved. Exhibit A is incorporated herein and made a part hereof by this reference

Section 3. Authorization. The City Manager is hereby authorized to enter into an agreement under the terms specified herein, to procure the vehicles under the Florida Sheriffs Association Contract with Duval Ford and under the Florida State Contract with NORTRAX, subject to approval as to form and legal sufficiency by the City Attorney, to transfer \$141,224.66 from Account No. 001.80005.500633 to Account No. 001.80005.500641 for the purchase and to expend funds in furtherance thereof in amounts not to exceed \$141,224.66.

Section 4. Implementation. The City Manager and the City Attorney are hereby authorized to take such further action as may be necessary to implement the purpose and the provisions of this Resolution.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.

The foregoing Resolution was offered by Councilmember Rodriguez who moved its adoption. The motion was seconded by Councilmember Mariaca and upon being put to a vote, the vote was as follows:
