A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO AN AGREEMENT WITH DORAL SOCCER CLUB, INC., THE THEATRE INSTITUTE, CRISTI'S DANCE STUDIO, ALEX OTHON'S BASEBALL CAMP, AND THE DORAL ACADEMY CHARTER ATHLETIC DEPARTMENT FOR THE PROVISION OF SUMMER AND SPECIALTY CAMP SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, City of Doral seeks to provide summer and specialty camp services for the benefit of all its residents; and

WHEREAS, Five (5) proposals were received in response to the Request for Proposals (RFP) #2008-01 titled "Summer Camp Services" by the 11:00 a.m. deadline on February 8th, 2008; and

WHEREAS, after reviewing the five submittals, the RFP selection committee determined that the five proposals received met the requirements outlined in the RFP; and

WHEREAS, Staff respectfully requests that Council authorize the City Manager to negotiate and enter into an agreement with the following service providers for the provision of summer and specialty camp services:

- 1. Doral Soccer Club, Inc.
- 2. The Theatre Institute
- 3. Cristi's Dance Studio
- 4. Alex Othon's Baseball Camp
- 5. Doral Academy Charter Athletic Department

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA, AS FOLLOWS:

Section 1. The City Council of the City of Doral, Florida hereby authorizes the City Manager to negotiate and enter into an agreement with five summer and specialty camp providers specified in the above "whereas" clause for the provision of summer and specialty camp services for the City of Doral.

Section 2. This Resolution shall take effect immediately upon adoption.
