RESOLUTION Z05-41

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA APPROVING A VARIANCE FROM SECTION 33-20(C) OF THE MIAMI-DADE COUNTY CODE PERTAINING TO MINIMUM SETBACKS FOR SWIMMING POOLS FOR THE PROPERTY LOCATED AT 11009 NW 45 TERRACE, DORAL, FLORIDA; APPROVING A REAR PROPERTY LINE AND SIDE PROPERTY LINE SETBACKS; PROVIDING FOR RECORDATION; PROVIDING AN EFFECTIVE DATE

WHEREAS, Mr. And Mrs. Guba ("Applicants") have requested approval of a variance from Section 33-20(c) of the Miami-Dade County Code, which has been adopted by the City of Doral, on property located at 11009 NW 45 Terrace, Doral, Florida; and

WHEREAS, the property is zoned RU-3M (Minimum Apartment House District), however, was assigned to the RU-IMa (Modified Single Family Residential, Dimensional Requirements); and

WHEREAS, according to Section 33-20(c) of the Code, swimming pools in the RU-3M District must be setback a minimum of 10 feet from the side property line and 7.5 feet from the rear property line; and

WHEREAS, Applicants have requested a variance based on the criteria for variances provided for in Section 33-36.1(f)(10) of the Miami-Dade County Code as adopted by the City of Doral; and

WHEREAS, the City Council, after careful review and deliberation of staff's report and of the testimony and evidence before it, has determined that the Applicants

meet the requirements for a variance as provided for in Section 33-36 of the Miami-Dade County Code as adopted by the City of Doral;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DORAL, FLORIDA THAT:

- <u>Section 1</u>. The foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this Resolution upon adoption hereof.
- Section 2. The City Council of the City of Doral hereby approves Applicants' request for a side setback and rear yard setback variance as follows:
- (1) Applicants are granted a 3.5 foot setback variance allowing the swimming pool to be placed 4 feet from the rear property line instead of the required 7.5 foot minimum.
- (2) Applicants are granted a 5 foot side setback variance for the east side property line instead of the minimum swimming pool side yard setback of 10 feet.
- Section 3. In granting this variance, the City Council reviewed Section 33-36 of the Miami-Dade County Code, as adopted by the City of Doral, and found that:
- (1) The variance request was in harmony with the general appearance and character of the subject block face and would not result in a significant diminution of value to adjacent property.
- (2) The variance request will not be detrimental to public welfare in that it will not have a substantial impact on public safety.

(3) The variance request will not create a materially greater adverse privacy impact on adjacent residences than that permitted by the underlying district regulations.

Section 4. This Resolution shall be recorded in the Public Records of Dade County, Florida, with the Applicant to pay the costs thereof.

Section 5. This resolution shall become effective upon its passage and adoption by the City Council.

WHEREAS, a motion to approve the Resolution was offered by Councilwoman Ruiz, who moved its adoption. The motion was seconded by Councilman Van Name and upon being put to a vote, the vote was as follows:
